## WARRANTY COVERAGE:

MAPEI Corporation ("MAPEI"), subject to the terms and conditions set forth below, warrants that our products will be free from manufacturing defects and will not fail under normal usage for the applicable warranty period stated in this system limited lifetime warranty ("warranty"), when the products and Systems purchased are used within their shelf life and according to (a) the technical data sheets, installation instructions and other written materials issued by MAPEI for the products and Systems (collectively, the "Product Literature") which are in effect at the time of the installation and (b) governmental regulations and codes, and standard industry practices. For purposes of this warranty, "residential" means a job installation utilizing one or more MAPEI products and Systems at a single-family detached dwelling; "commercial" means a job installation utilizing one or more MAPEI products and Systems at multi-family residential projects (such as condominiums, cooperatives, apartments, timeshares and mandatory homeowner associations), public places and other commercial establishments. **FOR PURPOSES OF THIS WARRANTY, A "LIFETIME" MEANS FOR SO LONG AS THE JOB INSTALLATION REMAINS UNCHANGED, WITHIN THE STATED FLOORING MANUFACTURER'S PERFORMANCE WARRANTY PERIOD FOR THE PRODUCT AND SYSTEM INSTALLED, AND IS PROPERLY MAINTAINED ACCORDING TO MANUFACTURER'S WRITTEN INSTRUCTIONS.**

## EXCLUSIONS FROM WARRANTY COVERAGE:

Mapeheat floor-heating systems where electrical components were connected or tested by an unlicensed or otherwise unqualified electrician are excluded from coverage under this warranty. Mapeheat thermostats are specifically excluded from coverage under this System Limited Lifetime Warranty, as thermostats are limited and subject to MAPEI's 3-Year Limited Warranty. Non-residential commercial projects and public place projects are excluded, unless written pre-approval on a case-by-case basis was obtained by MAPEI's director of technical services. In addition, the following are specifically excluded from coverage under this warranty: exterior applications, submerged applications, applications involving glass tiles, resin-backed tiles, large-format tiles less than 5.5 mm in thickness, and/or moisture-sensitive stones. Also excluded are structural failure, inadequate subflooring, or improper subfloor preparation; damages caused by Acts of God, including, but not limited to hurricane, flooding, earthquake or other types of natural disasters, or as a result of unforeseen circumstances; acts of negligence, or product misuse or abuse; failure to comply with our Product Literature, applicable building codes and regulations, and standard industry practices; water damage; normal wear and tear resulting from usage; efflorescence and shading inherent in all cementitious products; cracking due to structural movement, excessive deflection or other failure of the substrate, including but not limited to substrate failures caused by Alkali Silica Reaction (ASR) or Near Surface Alkali Reaction (NSAR). It is expressly understood that your purchase of our products and Systems acknowledges that MAPEI is not responsible or liable under any circumstances for determining the suitability or compatibility of our products for the user's intended purpose.

## YOUR LEGAL RIGHTS:

This constitutes your entire express warranty for the products purchased. To the extent permitted by law, all other warranties, whether express or implied, including, but not limited to the implied warranties of **MERCHANTABILITY** and **FITNESS FOR A PARTICULAR PURPOSE** are EXCLUDED. ANY IMPLIED WARRANTIES ARISING BY OPERATION OF LAW ARE LIMITED IN DURATION TO THE TERM OF THIS WARRANTY. MAPEI WILL NOT PAY OR BE LIABLE UNDER ANY CIRCUMSTANCES FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL OR EXEMPLARY DAMAGES, OR FOR LOST PROFITS OR BUSINESS INTERRUPTION LOSS. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. No express or implied warranty can be modified by any course of dealing, course of performance or usage of trade. This warranty gives you specific legal rights and you may also have other rights which vary from state to state. NO REPRESENTATION, PROMISE, AFFIRMATION OR STATEMENT BY ANY EMPLOYEE OR AGENT OF MAPEI WILL BE ENFORCEABLE AGAINST MAPEI UNLESS IT IS SPECIFICALLY INCLUDED IN THIS WARRANTY. This warranty: (a) shall commence on the date of installation and shall end as specified in this warranty; (b) is limited to the original purchaser and is nontransferable; (c) applies only to those installations that properly registered online at [www.mapeheatwarranties.com](http://www.mapeheatwarranties.com) within 30 days of installation and, (d) applies only to purchases and installations of the products within the United States on or after July 20, 2023.

## FILING A CLAIM:

To file a claim under this warranty, you must contact us, in writing, within fifteen (15) calendar days of the discovery of the alleged manufacturing defect in our products, at MAPEI Corporation, Attn: Technical Services Department, 1144 East Newport Center Drive, Deerfield Beach, Florida 33442. Proof of purchase of the system of MAPEI products must be submitted with any notice of claim. We have the right, without any obligation, to physically inspect, perform testing, and obtain samples at the site where the warranty claim occurred, or to engage an independent third party for those services before we determine the validity of your claim. In order to perform (or have performed) the services described in the prior sentence, the owner of the site consents to total access for such services and agrees to pay for those services and all related costs to MAPEI if the claim is invalid under this warranty. Your claim must be received and evaluated by us before any repair work is performed; otherwise, this warranty will be null and void. ## YOUR EXCLUSIVE REMEDY:

If your claim is valid under this warranty and our System is proven defective, you will receive as your exclusive remedy and at MAPEI's own option: (a) replacement product(s) for only that specific portion of the original installation requiring replacement or reimbursement of the purchased price of the original System or component MAPEI product proven to be defective or (b) payment of an amount for the purchased price of the original System or component MAPEI product proven to be defective. If the installation was done by a MAPEI Registered Pro Installer or an nVent NUHEAT Certified Pro Installer, you will receive reimbursement of your reasonable and substantiated material and labor costs for only that specific portion of the original installation requiring replacement, including flooring, not to exceed the per-square-foot cost of the original installation proven to be defective. Due to conditions beyond the control of MAPEI (e.g., color and shade availability, discontinuation, normal wear and tear), MAPEI cannot guarantee or warrant an exact match to the specific tile, stone, or other flooring materials used in the original installation. In such event, substantially similar materials shall be substituted.
