Product Line

Adesoguard is a self-adhered bitumen sheet membrane (single layer) used a moisture barrier for control of rising damp in concrete foundations, footings and slabs.

Product Description

Adesoguard SA is a self-adhered elastomeric bitumen sheet membrane (single layer) used in footings, block walls, retaining walls and under slab as a moisture barrier. Adesoguard has a polyester non-woven carrier stabilized with glass strands giving it excellent puncture resistance, tensile strength, and dimensional stability.

The Adesoguard SA is CE marked and product compliant with European standards. It has a cold flexibility of -25 C making it flexible at low temperatures.

Scope of use and design requirements

Adesogard SA 1.8mm and 1.5mm can be used on:

- Buildings subject to non-specific design under floor slabs complying with NZS 3604 and behind concrete masonry basement walls and under floor slabs complying with NZS 4229
- Within buildings subject to specific design with substrates of insitu or precast concrete complying with NZS 3101 or concrete masonry complying with NZS 4230 and 4210
- Subsoil drainage and free draining granular backfill must be placed behind basement walls
- Adesoguard SA must only be used in low water table conditions
- When used on block walls Adesoguard SA must be terminated both vertically and horizontally, with a mechanically fastened aluminium extrusion, using Polydetail MS compressed to terminate the bitumen edge
- All work must be protected from backfilling damage. Polyfond KIT drain must be used for drainage and protection.

Conditions and limitations of use

All building work must be undertaken by MBP (NZ) Ltd approved applicators. Where the work involves Restricted Building Work, this must also be completed by, or under the supervision of, a Licensed Building Practitioner (LBP) with the relevant license class.

For design and installation instructions refer to BRANZ (804) and the Adesoguard technical datasheet.
